Concurrent travel documents

Thank you for your application for a concurrent Australian passport. In order for us to consider your request, please complete the attached form.

If your proposed travel is business-related, your employer will need to complete Section B of the form and also provide a letter supporting your application. The completed form and supporting letter should be returned to this office.

If you require a concurrent passport because certain governments will not permit entry on a passport which shows you have visited, or intend to visit, countries with which they do not have normal diplomatic relations, you should find out whether the relevant visa-issuing authorities of those countries will provide you with a loose-leaf visa. As another option, you may want to consider obtaining a new Australian passport instead of a concurrent passport.

A concurrent passport will only be issued with a limited validity appropriate to your demonstrated travel needs, up to a maximum of three years. The normal application fee must be paid when applying for a concurrent passport (including a priority processing fee where appropriate) regardless of the validity period approved for the concurrent passport. The application fee is not refundable if your application is not approved.

Please note that if your application for a concurrent passport is approved, this will not constitute a general approval for the issue of future concurrent passports. Each application will be considered separately.
